Visa Information

Students coming to UAE for paid work, internship or any research purposes should not enter the country on a Tourist Visa.

Regardless of your nationalities, IAESTE UAE will apply for an e-Visa (entry permit) on the intern's behalf. We recommend that you do not buy your airplane tickets until you have received your e-Visa; as we cannot guarantee that your visa will be granted. IAESTE UAE will not be held liable for any costs incurred due to visa delay or rejection.

Requirements to apply for e-Visa:

1. A clear and valid copy of your passport (pdf)
2. A passport size photo with white background (43mm,w x 55 mm,h)-jpeg
3. Security clearance form (pdf)

You are required to email iaeste@sharjah.ac.ae with the subject email as: Offer Number – Intern Name – IAESTE Sending Country)

The visa will be based on how long the intern will stay in the country. Please refer the below:

*It should be noted that the figures above may vary from time-to-time. These are estimates and IAESTE UAE is not responsible for the decision taken by the authorities regarding changes to the fees

Interns who are coming to UAE for the first category and exceed the 60 days will pay a fine per day upon departure at the airport. If you are only having the option of less than 60 days, please make sure you exit the county before its expiry.

Once your visa is issued, we will email you the copy along with your accommodation and visa fees. You are required to pay the full amount in exact change of dirhams upon arrival. You will need to print your e-Visa to get it stamped at the airport. This document will be served to get the Emirates ID card.

For those staying for more than 60 days, we will proceed with medical checkup and other requirements. It is the responsibility of the intern to inform us your departure date to cancel the visa. You are required to submit your flight itinerary for this purpose at least 3 weeks before you leave the country.

Interns holding the e-Visa cannot leave the country or re-enter later. Therefore, you should be aware of such situations. IAESTE UAE is not liable for any cases that arises

Payment

All IAESTE interns are required to pay upfront the visa fees plus accommodation. The exact amount is expected to be paid to IAESTE UAE on the registration day:

AED 450 (Less than 60 days) or AED 920 (more than 60 days) + AED 30/per day (from check in to check out)
